Combined PGY1/PGY2/MHA Health-System Pharmacy Administration Residency and Fellowship

The Department of Pharmacy Services at Providence Southwest Washington offers a combined PGY1/PGY2/MHA Health-System Pharmacy Administration Residency and Fellowship in collaboration with the University of Providence School of Health Professions. This 36-month program will train residents to assume senior management, supervisory and leadership responsibilities within health-system pharmacy.

Year 1: PGY1 Pharmacy Practice

You will be a member of the PGY1 Pharmacy Residency class at Providence St. Peter Hospital.

Year 2: PGY2 Health-System Pharmacy Administration

You will complete the requirements of the PGY2 Health-System Pharmacy Administration program. You also will participate in all aspects of administration and management of pharmacy services.

Master of Healthcare Administration (MHA)

Your MHA coursework will be completed during the PGY1 and PGY2 residency years.

Year 3: Administrative Fellow (work commitment)

Upon completion of the PGY1/PGY2/MHA program, you will work as an Administrative Fellow, Pharmacy Services for one year. As part of the Pharmacy Leadership team, the Administrative Fellow will have administrative responsibility and authority for assigned areas within the Southwest Washington Service Area of Providence.

PGY1/PGY2/MHA Health-System Pharmacy Administration Residency and Fellowship

The University of Providence School of Health Professions is proud to offer an innovative platform that allows residents in the Providence Southwest Washington combined PGY1/PGY2 program to simultaneously enroll for the MHA degree. The program is designed to take advantage of efficiencies in both the residency and MHA programs.



The program is designed to prepare pharmacists for careers that require expertise in both pharmacy and business theories and principles. The program is directed toward providing didactic and experiential education to MHA students that will allow them to: (1) understand the major administrative functions in organizations delivering pharmaceutical products and care to patients; and (2) design strategies and policies to cope with the evolving health care environment. Supplemental projects will aid in developing administrative, research and analytical skills, in addition to improving the resident's understanding of pharmacy practice and administration in health-systems.

- Eight-week online courses for working professionals with short breaks between courses
- Cohort model in which students gain a sense of community and individual attention as they progress through the program with the same group of students
- · Opportunity to receive a quality education with a direct connection to the healthcare industry
