About Providence Saint Joseph Medical Center

Located just north of Los Angeles in Burbank, California, Providence Saint Joseph Medical Center (PSJMC) with 392 licensed beds provides a full range of diagnostic, treatment, care and support services for the San Fernando Valley communities. Founded in 1943 by the Sisters of Providence, PSJMC is a non-profit community hospital known for its state-of-the-art technology and high quality, compassionate care. PSJMC offers comprehensive inpatient and outpatient health care services, including The Disney Family Cancer Center, Neuroscience and Rehabilitation Services, Women's Health Services, a Neonatal ICU, The Bariatric Wellness Center, an accredited Stroke Center, as well as Emergency Department care (including designation as a STEMI receiving facility).

The pharmacy department provides 24-hour care, with clinical services supported using a decentralized staffing model. Services include Antimicrobial Stewardship, TPN dosing and monitoring, glucose management, anticoagulant dosing and monitoring, and transition of care activities.

Accredited by ASHP since 2009, Providence Saint Joseph Medical Center's residency program is designed to prepare a motivated, self-directed individual to become a confident and competent clinical pharmacist. This program emphasizes personal and professional growth, enhancement of leadership skills, and development of clinical knowledge for the provision of patient-specific, evidence-based care. PSJMC provides a challenging and dynamic environment for the pharmacy resident to hone communication, teamwork, and problem-solving skills. We are looking for highly skilled and motivated new graduates who want to train to be pharmacists in an acute care setting. Learning experiences are designed to allow the resident to develop the necessary skills to succeed in acute care practice. Rotation length may vary depending on the needs and interests of the resident.

Residency Requirements

The resident will have completed a Pharmacy Doctorate program from an accredited college of pharmacy and have a California intern license or pharmacist license prior to beginning the program on July 1. It is expected that the resident will be a licensed pharmacist in the state of California within 120 days after the residency program start date. The resident schedule consists of a 40-hour work week that includes two weekends a month. The resident will also participate in activities necessary for maintaining accreditation and is expected to precept fourth year pharmacy students on clinical rotations.

Compensation and Benefits

Compensation for the 52 week residency position is approximately \$60,000. Benefits include medical, dental, and vision coverage, as well as paid vacation time. Residents receive their own work area with computer, hospital phone extension, and travel and registration reimbursement for residency related conferences. Required conference days are scheduled as working days and are compensated by the program.

How to Apply

PSJMC participates in the ASHP Pharmacy Online Residency Centralized Application Service (PhORCAS) program and the ASHP Matching Program. Applicants must submit all application materials through PhORCAS, including:

- Letter of intent: Include reasons for seeking a residency at PSJMC and how you can contribute to PSJMC's program
- · Curriculum Vitae
- · Academic transcripts
- Three letters of recommendation (one from a faculty member and one from an employer is preferred)

Applicants offered an interview will be notified by the Residency Program Director. Interviews will be scheduled from the end of January through February.
