Post-Graduate Year 1 (PGY1) Residency Program

The Providence Medford Medical Center PGY1 Residency Program is built upon a tradition of excellence in pharmacy services. Providence pharmacy departments in Oregon are leaders in the implementation of technology and progressive pharmacy services. Our program has been accredited by the American Society of Health-System Pharmacists since 2016.

The PGY1 program is an integrated health system residency offering learning experiences throughout Providence in Medford. The program offers support for advanced practice-based skills in a variety of practice settings and patient populations, development of leadership skills, training in evidence-based medicine, involvement in strategic initiatives, and exposure to a variety of potential practice settings of interest including administration, acute care, ambulatory care and critical care.

Our residents also have the opportunity to earn a teaching certificate through the Oregon Pharmacist Teaching Certificate Program, an arrangement between region residency programs, Oregon State University College of Pharmacy, and Pacific University School of Pharmacy.

The Program

The purpose of the Providence Medford Medical Center PGY1 Residency Program is to build on Doctor of Pharmacy (Pharm.D.) education and fully prepare residents to seamlessly transition into successful careers in acute care clinical pharmacy, obtain board certification, or pursue further postgraduate year two (PGY2) pharmacy residency training.

Providence Medford Medical Center is a 168 licensed bed community hospital located in beautiful Southern Oregon. At Providence Medford Medical Center, our PGY1 Residency Program trains residents in a not-for-profit community hospital with outsized opportunities due to the resources and expertise available as part of a large, progressive health system. Our caregivers pride themselves on our tightknit community, our Mission driven service, and the role that Providence Medford Medical Center takes in serving those who are poor and vulnerable in Southern Oregon.

Services offered locally include emergency services, internal medicine, critical care, stroke care, cardiac and vascular care, birth center, total joint replacement and spine health programs, robotic surgery, pain management services, and a comprehensive rehabilitation program.

By the end of the program, the resident should be able to:

- · Manage and improve the medication-use system, including patient safety and quality-improvement processes
- Provide evidence-based, patient-centered medication therapy management with interdisciplinary teams
- Exercise leadership and practice management skills in an integrated health care model
- Demonstrate project management skills to achieve defined outcomes
- · Provide medication and practice-related education and training



Program Structure

The traditional PGY1 residency program will provide the resident with exposure to multiple areas of pharmacy practice including direct patient care rotations in both acute and ambulatory care. Required staffing will occur within the Acute Care Department of Providence Medford Medical Center.

Residents will have an additional protected time for research, participation in the residency interview process, and other project work.
